AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF DANIA BEACH, FLORIDA, AMENDING ARTICLE 1 OF CHAPTER 6; BEACHES, PARKS & RECREATION, SECTION 6-9, ANIMALS ON BEACHES, BEACH PARKS AND IN PARKS OF THE CITY CODE OF ORDINANCES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; FURTHER, PROVIDING FOR AN EFFECTIVE DATE.

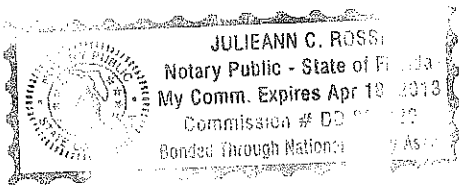
