Consideration of the Abatement Request for: Violet M. Klatt Rev Tr, 100 S. Federal Highway #201, Case #09-0073

Summary Explanation & Background:

This was originally cited on January 20, 2009 for 2 violations, and was given 30 days to comply. This went to the Special Magistrate on 4/02/09 for 2 violations. The Special Magistrate issued an order giving the respondent until 5/12/09 to comply or a fine of \$200.00 per day would be levied. Special Magistrate Mark Berman ordered the fine confirmed at the 10/08/09 hearing. At the 6/03/10 hearing Special Magistrate Mitch Kraft granted an authorization to foreclose. The fines ran from 5/12/09 through 6/18/10, 402 days @ \$200.00 per day = \$80,400.00. An abatement of \$8,000.00 was recommended to the City Commission per Special Magistrate Mitch Kraft at the September 2, 2010 Special Magistrate hearing. A continuance was requested by the respondents from the September 16, 2010 Commission Abatement hearing. A continuance was again requested by the respondents from the November 18, 2010 Commission hearing.

This proceeding came on for Formal Hearing on April 2, 2009, after notice. Based upon the evidence presented, the Code Compliance Special Magistrate makes the following findings of fact and conclusions of law:

- a. The Code Compliance Special Magistrate has jurisdiction of the Respondent(s) and the subject matter of this action.
- b. The Respondent(s) or a representative for the Respondent(s) was not present at the hearing.
- c. Respondent(s), Violet M Klatt Rev Tr % Dania Shopping Plaza, did allow the following code violation(s) to exist at property Respondent(s) owns/own, located at 100 S. Federal Highway, Dania Beach, Florida, which property is legally described as: TOWN OF DANIA B-49 D LOT 1 LESS ST RD,2,3,4 LESS ST RD, 5 LESS ST RD,6 BLK 25 (# 0234 01 3560):

Upon consideration by the Special Magistrate, it is ORDERED:

1. Respondent(s) has/have been found to be in violation of the above described code section(s) listed in paragraph(s) c.(1). A fine of \$200.00 per day will begin running on May 12, 2009.


The City of Dania Beach shall have and recover from Respondent(s), for the foregoing violations listed above, a fine of \$200.00 per day beginning May 12, 2009.

The fine shall continue until the violations come into compliance with the sections of the City Code upon requested inspection. Upon complying, the Respondent(s) MUST notify the City's Code Compliance Department and an officer will inspect the property and notify the Code Compliance Special Magistrate whether Respondent(s) has/have complied. If the Respondent(s) does/do not notify the City's Code Compliance Department, an officer will not inspect the property and the fine will continue to be imposed each day until a Code Officer is notified, inspects the property and determines the property to be in compliance with this order. The fine shall constitute a lien upon the real property and personal property of the Respondent(s).

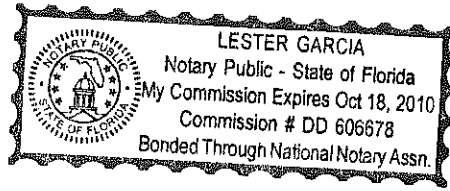

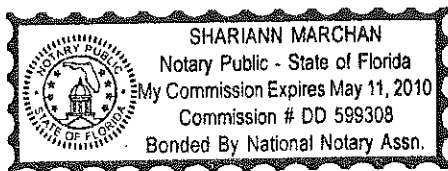
1. The Respondent(s) or a representative for the Respondent(s) was not present at the hearing.
