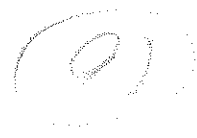

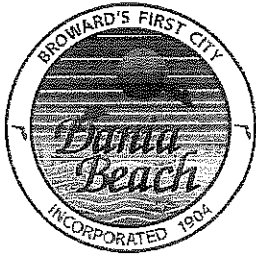

RE: Harold A. Davis / SW 6th Street  
Street Renaming Request – Address Verification

As per Section III: of the Street Renaming Procedures, research of the addresses within one-quarter-mile of SW 6th Street was performed.

- a) There are 17 properties which front on, back on or that have a mailing address containing the name of the affected street.

There are 18 signatures representing 8 of the properties which front on, back on or have a mailing address containing the name of the affected street on the petition.

- b) There are 111 properties within a quarter mile distance in all directions of the affected street. There are approximately 47 signatures with addresses within this radius. 20% of the 111 properties would require 22.2 signatures.
