Requesting Emergency Purchase Approval for Hector Turf Mower

Public Works added a CIP for purchase of a mower in June of last year, for FY 2011-2012. The estimated purchase price of the mower was \$24,526.00, from the quoting process. The final actual price quote obtained by Public Services from Hector Turf was \$25,286.75 and this price was used in preparing the recent purchased Resolution that the Commission approved.

The above quote was under a National Contract and was not available to be purchased according to City Purchasing Policy. Another quote, using a State of Florida Contract was obtained from a State equipment distributor and resulted in a price of \$25,535.96.

The City Commission at the May 22, 2012 meeting approved the quote of the National Contract, not the State Contract. Public Services used the wrong quote. The difference in price is \$249.21.

Finance indicated that Commission approval is needed for the increased cost of this capital purchase – but that your office may wish to approve an *emergency purchase* at the higher price in anticipation of future Commission approval so as to allow Public Services to place the order for this mower now.

Work started on C.W. Thomas Football field in May of 2012, this mower will be required once work is completed. If Sports Turf One (installer of the grass on the football field) mow the grass it would cost the City \$800 each time, with at MOST a week in between mowings. Sports Turf One has previously mowed the field. If we wait to request approval of the additional money at either the June 26 or the July Commission meeting, this would incur costs of maintaining the grass on the football field of \$2,400 and almost \$6,000 if we present this item to the Commission at the July meeting.

It is recommended by Public Services that emergency purchase approval be granted by the City Manager including the increased \$249.21. This will allow Public Serices to purchase this mower from Hector Turf/Wesco Turf in anticipation of Commission approval at the next meeting. This will save the Landscape Department thousands of dollars and the field will be ready to be used for the upcoming Dania Bears Football Team.

RESOLUTION NO. 2012-065

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DANIA BEACH, FLORIDA, AUTHORIZING THE PROPER CITY OFFICIALS TO PURCHASE FROM HECTOR TURF, A TORO GROUNDSMASTER 3505-D ROTARY MOWER, MODEL NO. 30849 WITH ACCESSORIES, UNDER STATE CONTRACT NO. 760-000-10-1 PRICING, FOR AN AMOUNT NOT TO EXCEED \$25,286.75; PROVIDING FOR CONFLICTS; FURTHER, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Charter of the City of Dania Beach, Part III, Article 3, Section 4, Subsection (j), authorizes the City Manager to purchase supplies, services, equipment and materials for the City government in amounts in excess of the established monetary threshold without competitive bidding and without advertisement for bids if he is authorized to do so in advance by a resolution adopted by the city commission; and

WHEREAS, the Dania Beach Code of Ordinances, Chapter 2, Article 1, Section 2-10, "Monetary thresholds for certain purchases and payment disbursement authorizations", Subsection (a), sets the monetary threshold or limitation at \$25,000.00; and

WHEREAS, the City Commission previously approved a \$24,526.00 budget appropriation in the General Fund, Public Services – Parks Maintenance Division for the capital purchase of a rotary mower; and

WHEREAS, the City Manager has determined that such equipment can be purchased at the least cost to the City from Hector Turf in the amount of \$25,286.75, as shown in Exhibit "A", which exhibit is made a part of and is incorporated into this Resolution by this reference; and

WHEREAS, the City Purchasing Contract Coordinator has reviewed the Purchasing Policy and has determined that this recommended purchase meets competitive conditions of the City's Purchasing Policy requirements; and

WHEREAS, the Public Services Department has available funds to transfer the additional \$760.75 funding appropriations needed to provide for a total funding amount of \$25,286.75 for this purchase;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DANIA BEACH, FLORIDA:

<u>Section 1.</u> That the foregoing recitals are incorporated into this Resolution by this reference.

Section 2. That the proper City officials are authorized to purchase from Hector Turf, a Toro Groundsmaster 3505-D Rotary Mower, Model No. 30849, in an amount not to exceed the sum of \$25,286.75 (Twenty-Five Thousand Two Hundred Eighty-Six Dollars and 75 cents) for the Public Services Department.

Section 3. That funding for this equipment purchase is reflected in the 2012 General Fund - Public Services Parks Maintenance Account No. 001-3904-572-64-30 in an amount of \$24,526.00, and the Public Services Department agrees to transfer available funds in an amount of \$760.75 from Account No. 001-39-04-539-46-50 to provide for the total funding in the amount of \$25,286.75 for this purchase.

Section 4. That all resolutions or parts of resolutions in conflict with this Resolution are repealed to the extent of such conflict.

Section 5. That this Resolution shall become effective immediately upon its passage and adoption.
