This memorandum is being submitted to request the expenditure of LETF dollars for the purchase of equipment for use by the Dania Bears Athletic Club. This will benefit the Dania Beach District inasmuch as it has been demonstrated that children otherwise occupied with wholesome athletic activities are far less likely to become involved in criminal activity. Furthermore, this partnership between the Broward Sheriff's Office and the Dania Bears Athletic Club fosters the relationships between our deputies and youth in Dania Beach.

This request is for athletic equipment for the Dania Bears, which is specified in the attached request letter. This is a worthwhile and long-standing youth football program that operates out of CW Thomas Park. We have partnered with them in each of the past five seasons by making a monetary donation to assist them with their needs and, in turn, they have provided over 300 boys and girls with the opportunity to participate in a well organized successful sports program. If approved, the total amount of this request would be for \$2,500.00. Additionally, I have attached our most recent LETF balance sheets from the City of Dania Beach showing a balance of \$29,520.53 in state funds and \$131,295.16 in federal funds.

This request has been reviewed and approved by BSO command staff and legal counsel. I would appreciate it if you would favorably endorse this request and am prepared to discuss it with you and/or our elected officials at your convenience.
