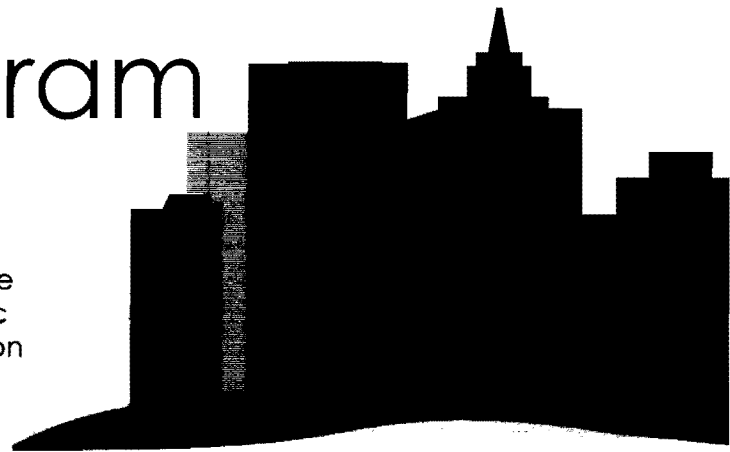

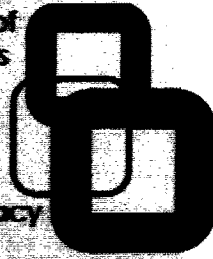




**Marie Lopez Rogers** is president of the National League of Cities and mayor of Avondale, Arizona, where she was elected as the city's first Latina mayor in 2006. A lifelong resident of Avondale who grew up working side-by-side

with her parents in the small migrant labor camps around the city, she has served on the city council since 1996. Today she is guiding the transformation of one of the nation's fastest growing municipalities and is directly engaged in shaping the future of the region's economic, social and cultural vitality.

In her position as president of the National League of Cities, she helps to guide the advocacy efforts on Capitol Hill on behalf of more than 19,000 cities and towns represented by NLC.



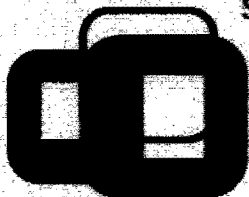

*Socialnomics* was a finalist for the "2010 Book of the Year" awarded by the American Marketing Association. Qualman produced "Social Media Revolution", the most viewed social media video series in the world, which has been used by organizations from NASA to the National Guard. *Fast Company Magazine* listed him as a Top 100 Digital Influencer.

Qualman is an MBA Professor at the Hull International Business School. For the past 18 years, Qualman has helped grow the digital capabilities of many companies including Cadillac, EarthLink, EF Education, Yahoo, Travelzoo and AT&T. He is the founder and owner of *socialnomics.com*, which *PC Magazine* ranks as a Top 10

Social Media Blog. He sits on the Boards of Manumafix, Bazaarvoice Inc., and WannabeeSocial. Qualman holds a BA from Michigan State University and an MBA from The University of Texas.

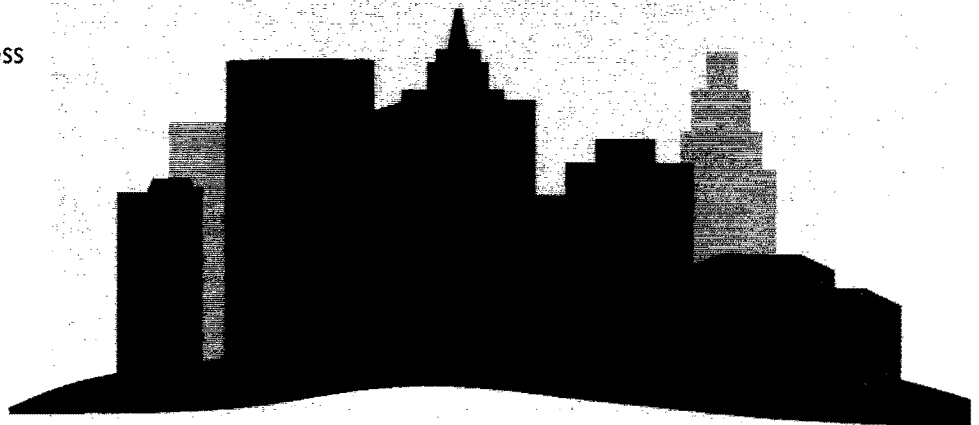

Franklin Deese was born in the late 1950s, facing segregation and racism. He grew up in the turbulent 1960s amidst the Civil Rights Movement and efforts to end racial discrimination. He came of age in the 1970s, unable to avoid a system that promoted experimentation with drugs, sex and street life. By the 1980s he was convicted for robbery and spent his early adulthood in the prison system.



In 1989, he was paroled with the clothes on his back and \$30.00 in his pocket, facing a daunting challenge to make a life for himself. Through study, mentorship and self-examination, he moved the mountains from his path and eventually rose to be mayor of the Town of Marshville, North Carolina. He is the only African American in the nation to serve 10 years in the prison system as a felon and then be elected to the top job in a city in the same county in which he was convicted. Deese chronicles his struggles and achievements in his book *From Inmate to Mayor*.
