He violation from 7/2	Case #10-0434: This case was originally cited against the previous owner, Kwok Keung Lai, on 4/9/10 for 8 violations and was given 30 days to comply. This went to the Special Magistrate on 6/3/10 for 8 violations. Special Magistrate Mitchell Kraft issued an order giving the respondent until 7/13/10 to comply or a fine of \$250.00 per day would be levied. At the 9/2/10 hearing, Special Magistrate Mitchell Kraft confirmed the fine as a lien. He also granted the City authorization to abate any of the existing public nuisance violations on the property. The property came into compliance on 6/21/13. The fines ran from 7/13/10 through 6/21/13, 1,074 days @ \$250.00 per day = \$268,500.00 plus admin fees of \$268.00 for a total of \$268,758.00.

Special Magistrate Mark Berman issued an order giving the respondent until 5/14/11 to comply or a fine of \$150.00 per day would be levied. At the 9/8/11 hearing, Special Magistrate Gordon Linn confirmed the fine as a lien. At the 7/12/12 hearing, Special Magistrate Gordon Linn granted authorization to foreclose. The property came into compliance 6/21/13. The fines ran from 5/14/11through 6/21/13, 769 days @ \$150.00 per day = \$115,350.00 plus admin fees of \$254.50 for a total of \$115,604.00.
