#### **Requested Action:**

Approval of the Settlement Received for: Kim F Boocher and Timothy Boocher, 203 SE 5 Street, Case # 10-0701

#### Summary Explanation & Background:

This was originally cited on 5/28/10 for 4 violations, and was given 10 days to comply. This went to the Special Magistrate on 7/8/10 for 4 violations. Special Magistrate Mark Berman issued an order giving the respondent until 7/29/10 to comply or a fine of \$200.00 per day would be levied. At the 4/7/11 hearing, Special Magistrate Mark Berman confirmed the fine as a lien. At the 2/7/13 hearing, Special Magistrate Mark Berman granted authorization to foreclose. The property came into compliance on 11/14/11. The fines ran from 7/29/10 through 11/14/11, 473 days @ \$200.00 per day = \$94,600.00 plus admin fees of \$262.00 for a total of \$94,862.00. There are also 4 Public Services liens that total \$1,363.00 and are included in this settlement.

This is a motion to accept the settlement offer received by the City due to foreclosure. The City received \$6,000.00 as settlement for the code case.
