## TWO (2) YEAR EXTENSION OF AGREEMENT BETWEEN THE CITY OF DANIA BEACH AND WESTREC MARINA MANAGEMENT, INC., RELATING TO MANAGEMENT SERVICES OF THE DANIA BEACH MARINA

This is an extension (the "Extension") of an Agreement (the "Agreement") which Agreement exists between the City of Dania Beach, Florida, a Municipal corporation, and Westrec Marina Management, Inc., a California corporation, authorized to conduct business in the State of Florida (the "Contractor"). This Extension is entered into and becomes effective retroactively to October 1, 2012; a copy of the original Agreement is attached as Exhibit "A", which is made a part of and incorporated into this Extension by this reference. City and Contractor wish to extend the Agreement.

In consideration of the mutual covenants, terms and conditions contained in the Agreement and this Extension, and other good and valuable consideration, the adequacy and receipt of which are acknowledged, the parties agree as follows:

- 1. This Extension to the Agreement that expired on September 30, 2012 shall remain in force and effect retroactively to October 1, 2012, for an additional two (2) year period, up to and through September 30, 2014.
- 2. That compensation for the maintenance services for the two (2) year extension period will be in an amount not to exceed One Hundred Fifteen Thousand, Five Hundred Sixty-Six Dollars (\$115,566.00).
- 3. That in all other respects the Agreement is ratified and reaffirmed and remains in full force and effect.
