#### Summary Explanation & Background:

This was originally cited on 6/11/07 for 2 violations. This went to the Special Magistrate on 9/10/07 for 2 violations. Special Magistrate Mitchell Kraft issued an order giving the respondent until 12/9/07 to comply the violations or a fine of \$150.00 per day would be levied. At the 2/4/08 hearing Special Magistrate Gordon Linn granted an extension to 5/14/08. At the 7/9/09 hearing Special Magistrate Mark Berman confirmed the fine as a lien. The property was brought into compliance on 4/21/14. The fines ran from 12/9/07 through 4/21/14, 2,325 days @ \$150.00 per day = \$348,750.00 plus recording/admin fees of \$141.00 totaling \$348,891.00. At the 7/10/14 hearing, Special Magistrate Gordon Linn recommended an abatement of the fine to \$34,000.00 to the City Commission. The out of pocket costs to the City are \$2,000.00.




