Consideration of the Abatement Request for: TS Property Management c/o AJM Capital LLC, NW 5 Avenue (Vacant Lot), Case No. 2012-1092

Summary Explanation & Background:

This was originally cited on 11/5/12 for 2 violations. This went to the Special Magistrate on 1/10/13 for 2 violations. Special Magistrate Gordon Linn issued an order giving the respondent until 2/19/13 to comply the violations or a fine of \$150.00 per day would be levied. At the 6/6/13 hearing Special Magistrate Mark Berman confirmed the fine as a lien. At the 1/9/14 hearing, Authorization to Foreclose was granted by Special Magistrate Mark Berman. The property was brought into compliance on 5/29/14. The fines ran from 2/19/13 through 5/29/14, 464 days @ \$150.00 per day = \$69,600.00 plus recording/admin fees of \$254.00 totaling \$69,854.00.There is also a Public Service Abatement Lien on the property for approximately \$565.00 that is combined with the vacant lot adjacent to this property and was recorded on April 20, 1994. At the 8/7/14 hearing, Special Magistrate Mark Berman recommended an abatement of the fine to \$7,000.00 to the City Commission. The out of pocket costs to the City are \$1,500.00.

FINAL ORDER OF THE DANIA BEACH CODE COMPLIANCE SPECIAL MAGISTRATE

This proceeding came on for Formal Hearing on January 10, 2013, after notice. Based upon the evidence presented, the Code Compliance Special Magistrate makes the following findings of fact and conclusions of law:

a. The Code Compliance Special Magistrate has jurisdiction of the Respondent and the subject matter of this action;

and

b. Respondent, T S Property Management, did allow the following code violations to exist at property Respondent owns, located at vacant lot at NE corner of NW 5 Avenue and NW 2 Street, Dania Beach, Florida, which property is legally described as: TOWN OF MODELO (DANIA) B-49 D LOT 23 BLK 3: (0234 01 0330).

2. DBCC 13-34 (a) Nuisance Accumulation. It is unlawful for any owner or operator of premises within the city to allow the accumulation of or to accumulate any garbage, litter, stagnant water, trash, untended vegetation, or to allow any discoloration, or any nuisance as defined in section 13-21 upon the premises. There is trash, litter and untended vegetation on the premises.

3. DBCC 13-34 (b) Property and Right of Way Maintenance. Each owner or operator of property within the city shall keep such property, and the adjoining unpaved portions of the public rights-of- way, swales and canal banks, clean and free from any

accumulation of garbage, trash, and litter. There is trash, litter and untended vegetation on the property and rights of way adjoining the property. Cut all untended vegetation and remove all trash and litter on the property and rights of way adjoining the property. Upon consideration thereof, it is thereupon ORDERED:

1. Respondent, T S Property Management:

(a) has been found to be in violation of the above described code sections listed in paragraphs b.(1) and b.(2) and a fine of \$150.00 per day will begin running on February 19, 2013 for the violations. The violations listed in paragraphs b.(1) and b.(2) present a serious threat to the public health, safety and welfare since the trash, litter and overgrown vegetation on the property and rights of way adjoining the property attract rats and other vermin. The violations listed in paragraphs b.(1) and b.(2) must be complied by February 19, 2013, or the City is authorized to remove the violations described above by cutting all overgrown grass and weeds and removing all trash and litter, and the City's reasonable cost for corrective action shall be charged to Respondent, along with the fine imposed in this Final Order.

(b) <u>In addition, there is also assessed \$100.00 to cover costs incurred by the</u> <u>City in the prosecution of this matter</u>. Said amount is now due, and must be paid prior to the compliance date as ordered. If not paid, this cost assessment may also constitute a lien against the above referenced property which may also be actionable by law.

The fine shall continue until said violations come into compliance with said sections of the City Code upon requested inspection. Upon complying, <u>the Respondent MUST notify</u> the City's Code Compliance Department and an officer will inspect the property and notify the Code Compliance Special Magistrate whether Respondent has complied. If the Respondent does not notify the City's Code Compliance Department, an officer will not inspect the property and the fine will continue to be imposed each day until a Code Officer is notified, inspects the property and determines the property to be in compliance with this order. Said
