Dave,

Per our agreement, and due to the May 2014 increase in the Tampa Green Markets Sulfur posting to \$133.00 (attached), we will adjust your acid pricing effective June 1st to \$135.21.

Your acid price increase is \$21.46 per ton. This is figured using (\$133 - \$75 = \$58) for the sulfur change and $(58 \times .37 = $21.46)$ for your acid price change.

This price change will affect all members of your co-op which include Cooper City, Deerfield Beach, Ft. Lauderdale, Hallandale, Hollywood, Miramar, North Miami Beach, Pompano Beach, and Sunrise. Please let me know if I have missed any members.
