Case #11-1008
This was originally cited on $6/15/11$ for 6 violations, and was given 15 days to comply. This went to the Special Magistrate on $10/6/11$ for 7 violations. Special Magistrate Mark Berman issued an order giving the respondent until $1/14/12$ to comply or a fine of \$150.00 per day would be levied. At the $5/3/12$ hearing, Special Magistrate Mark Berman granted an extension to $6/12/12$ . At the $2/7/13$ hearing, Special Magistrate Mark Berman confirmed the fine as a lien. The property came into compliance on $2/28/13$ . The fines ran from $6/12/12$ through $2/28/13$ , $261$ days @ \$150.00 per day = \$39,150.00 plus admin fees of \$174.50 for a total of \$39,324.50.
