
Current Developments


The GFOA's annual conference offers a uniquely practical way to keep up with all the most recent developments in public finance, whether it be the latest in the world of governmental accounting and financial reporting (proposed new guidance on other postemployment benefits and leases, meeting the audit challenge created by the latest pension standards, complying with OMB's new "Super Circular"); "what's new" out of Washington (Affordable Care Act ramifications); or advances and other developments in budgeting (resiliency/sustainability, lean applications), cash management, debt and economic development, and employee benefits.

CPE Credits

It is possible to earn up to 21 continuing professional education (CPE) credits at the GFOA's annual conference. Additional CPE credits can be earned by attending one or more of the GFOA's preconference seminars.

The GFOA is registered with the National Association of State Boards of Accountancy (NASBA) as a sponsor of continuing professional education on the National Registry of CPE Sponsors. New technology, process improvement, and focus on outcomes have enabled many organizations to evolve their procurement function. This seminar will cover new best practices in purchasing based on the Principles and Practices of Public Sector Procurement (http://principlesandpractices.org/) resources developed by the National Institute of Governmental Purchasing. Speakers will discuss how to integrate the best practices into high-performing finance organizations to create policies and processes around lease-purchase decision making, the evaluation process, performance-based contracting, cooperative contracts, outsourcing, and more.

Strategic Planning

The strategic planning process is important to identifying priorities, setting overall goals, defining key actions, and communicating to stakeholders. Once created, the strategic plan then becomes the foundation for many other activities, such as budgeting and financial planning. It is important, therefore, that the strategic plan be realistic, relevant, and connected to or aligned with other planning processes. When done correctly, strategic planning can be a invaluable tool for the finance officer. This kind of information typically requires a government to go beyond posting its CAFR or budget document online to include creative use of online tools, strategic communications, and other innovative public outreach methods. A more informed public can help provide government with many benefits—from greater public participation and engagement, to improved trust, to enabling collaboration to help solve challenges. Attend this seminar to hear case studies, lessons learned, tips, and effective strategies from leading practitioners who have developed innovative methods of taking an often complex subject matter to a wide audience. 


Southeastern Pennsylvania Transportation Authority

Guaranteeing Your Room Reservation

Experient is the Official Housing Provider for the GFOA 109th Annual Conference. The GFOA has worked diligently with the hotels in Philadelphia to establish room blocks for attendees and exhibitors. Improper solicitation of hotel reservations from any company or housing provider other than Experient is not approved by the GFOA. Reservations made by unaffiliated organizations may appear to be for lower rates, however, they may be illegitimate, have unreasonable cancellation or change penalties, or be completely non-refundable. Please be aware of, and report any unauthorized solicitation to the GFOA.

Reservations will be processed on a first-come, first served basis. A hotel is assigned in order of your preference, as available, or closest to event if not available. You can expect to receive a confirmation within two business days of booking your room reservation. If you have not received your acknowledgement by Wednesday, April 29, 2015, please contact the GFOA Housing Department at GFOA@experient-inc.com or 1-800-650-6835 (international callers 1-847-996-5874).

A major credit card number valid until June 2015 or later or a check for one night's room and tax (add 15.5% tax) is required to secure a reservation. Credit cards are for guarantee only and are not charged to hold reservations. A charge of one night's room and tax will be charged or forfeited on reservations that do not arrive (no-show) and were not cancelled before 72 hours of arrival. Early departures after check-in are subject to penalty fees set by hotel.

Checks must be received by April 29, 2015, and must be made payable to Experient/GFOA Housing. Reservations indicating a deposit guarantee, for which no check has been submitted, are subject to cancellation. Please base the amount of the check on the rate at the hotel of

your first preference. Note: Institutional purchase orders are NOT accepted. Cancellations within 72 hours of arrival will forfeit one night's room and tax. Refunds to those who guaranteed accommodations with a check deposit will be mailed after the end of the event.






