Summary Explanation & Background:

Case #07-0008: This case was cited on 1/2/2007 for 15 violations. This went to the Special Magistrate on 4/9/2007 for 12 violations. Special Magistrate Mark Berman issued an order giving the respondent until 6/9/2007 or a fine of \$200.00 per day would be levied. At the 8/6/07 hearing Special Magistrate Mark Berman granted an extension to 10/5/07. At the 12/3/07 hearing Special Magistrate Gordon Linn granted an extension to 3/12/08. At the 5/1/08 hearing, Special Magistrate Mitchell Kraft granted an extension to 7/10/08. At the 11/6/08 hearing, Special Magistrate Mitchell Kraft confirmed the fine as a lien. Special Magistrate Mitchell Kraft granted the fine as a lien. Special Magistrate Mitchell Kraft granted the fine as a lien. Special Magistrate Mitchell Kraft granted the fine as a lien. Case #11-1429: This case was originally cited on 8/3/2011 for 1 violation. This went to the Special Magistrate on 12/8/2011 for 1 violation. Special Magistrate Mark Berman issued an order giving the respondent until 2/16/2012 or a fine of \$100.00 per day would be levied. At the 1/10/2013 hearing Special Magistrate Gordon Linn confirmed the fine as a lien. Authorization to Foreclose was granted by Special Magistrate Mark Berman at the 8/1/2013 hearing. The fines ran from 2/16/2012 to 1/28/2015 for a total of 1,077 days @ \$100.00 per day = \$107.700.00 plus recording/admin fees of \$229.00 for a total of \$107,929.00. At the 5/7/15 hearing, Special Magistrate Bruce Jolly recommended an abatement of the fine to \$1,000.00 to the City Commission. The out of pocket costs to the City are \$1,000.00.

- DBCC 8-21 (a)(2)(g) window/door maintenance. Every window and exterior door shall be reasonably weathertight, maintained without cracks and holes, and in a good state of repair. Window and exterior door are in a good state of disrepair.
- 2. DBCC 8-21 (a)(2)(g) window equipment. All windows intended for ventilation must be equipped with fully operable hardware and fitted with screens. Failure The windows intended for ventilation are not equipped with fully operable hardware and fitted with screens.
- DBCC 8-21(a)(4)(a) building condition. Requires foundations, floors, walls, ceilings, roofs, roof surfaces, windows, doors and all other building parts to be structurally sound, weather proof and kept in a good state of repair. A hole exists in the building.
- 4. DBCC 8-21 (a) (5) (a) (1) building maintenance minimum standards. The exterior surface of the structure is deteriorated and must be painted.
- 5. DBCC 8-21 (a) (5) (a) (2) building maintenance minimum standards. All surfaces requiring painting or which are otherwise protected, maintained free of graffiti, and be of uniform colors void of any evidence of deterioration. The building exterior surface is deteriorated.
- DBCC 8-21 (a) (5) (d) vegetative materials standards. Live vegetative material shall provide complete coverage of the entire yard area exposed to public view. A portion of the yard lacks vegetation cover.
- 7. DBCC 13-34 (a) nuisance accumulation. There is unattended vegetation on the premises. All unattended vegetation must be cut.
- 8. DBCC 13-34 (b) health and sanitation nuisance. Each owner or operator of property within the city shall keep such property and the adjoining unpaved portions of the public rights of way, swales, and/or canal banks clean and free from any accumulation of garbage, trash, and litter. There is garbage, trash and litter on the property and swale area.
- 9. DBCC 28-4.20 (a) addition regulations standards. No building shall be erected, added on to, reconstructed or structurally altered, nor shall any building or land be used which does not comply with all the regulations established by this

chapter for the district in which the building or land is located. The subject property was altered by placing fill material on the property.

- 10. DBCC 28-4.20(d) prohibited use. Any use not specifically listed in the Schedule of Regulations as a permitted use or a special exception use is prohibited in all zoning districts. A shed was constructed on the property. It is prohibited to build a shed without permits.
- 11. DBCC 33-211 parking surface. All areas reserved for off street parking shall be hard surfaced. The parking area lacks an approved hard surface.
- 12. FBC 105.1 permits required. Construction work was performed without a permit. A rear window and door were installed and the garage was converted into a bedroom. Any owner or authorized agent that constructs, alters, or converts property must do so according to the Florida Building Code (2004), and obtain a required permit. Some of the permits are not finalized. Upon consideration thereof, it is thereupon ORDERED:

1. Respondent(s), Marayet Davis & Myra Thea Davis:

(a) has/have been found to be in violation of the above described code section(s) listed in paragraph(s) c.(1) through c.(12). A fine of \$200.00 per day will begin running on June 9, 2007.


