Requested Action:

Approval of the Settlement Received for: William Diaz, 911 NW 7 Street, Case #10-1769 and Case #11-1104 due to short sale

Summary Explanation & Background:

Case #10-1769

This was originally cited on 11/29/2010 for 1 violation, and was given 30 days to comply and then was granted a 30-day internal extension. This went to the Special Magistrate on 3/3/2011 for 1 violation. Special Magistrate Gordon Linn issued an order giving the respondent until 6/11/11 to comply or a fine of \$250.00 per day would be levied. At the 9/8/2011 hearing, Special Magistrate Gordon Linn confirmed the fine as a lien. At the 7/12/12 hearing, Special Magistrate Gordon Linn granted Authorization to Sue for Money Judgment. The fines ran from 6/11/2011 through 9/17/14, 1,194 days @ \$250.00 per day = \$298,500.00 plus admin fees of \$254.00 for a total of \$298,754.00.

Case #11-1104

This case was originally cited on 7/18/2011 for 1 violation and was given 30 days to comply. This went to the Special Magistrate on 12/8/2011 for 1 violation. Special Magistrate Mark Berman issued an order giving the respondent until 1/17/2012 to comply or a fine of \$100.00 per day would be levied. At the 7/12/2012 hearing, Special Magistrate Gordon Linn confirmed the fine as a lien. At the 4/4/2013 hearing, Special Magistrate Mark Berman granted Authorization to Sue for Money Judgment. The fines ran from 1/17/12 through 9/17/14, 974 days @ \$100.00 per day = \$97,400.00 plus admin fees of \$254.00 for a total of \$97,654.00.

This is a motion to accept the settlement offer received by the City due to short sale of the property. The City received \$7,500.00 as settlement for both code cases.
