This was originally cited on $8/30/2011$ for 1 violation. This went to the Special Magistrate on $11/3/2011$ for 1 violation. Special Magistrate Gordon Linn issued an order giving the respondent until $12/13/2011$ to comply the violation or a fine of \$150.00 per day would be levied. At the $7/12/12$ hearing Special Magistrate Gordon Linn confirmed the fine as a lien. The property was brought into compliance on $8/13/2012$ . The fines ran from $12/13/2011$ through $8/13/2012$ , 244 days @ \$150.00 per day = \$36,000.00 plus recording/admin fees of \$254.00 totaling \$36,854.00.
At the 4/2/15 hearing, Special Magistrate Bruce Jolly recommended an abatement of the fine to \$3,685.00 to the City Commission. <b>The out of pocket costs to the City are \$1,500.00</b>

Upon consideration thereof, it is thereupon ORDERED:

- 1. Respondent, DDRM Sheridan Square, LLC:
