Re: FLC Legislative Policy Committee Sign-Up - REVISED DATES

On behalf of President Matthew Surrency, the Florida League of Cities is pleased to announce the start of the League's legislative policy process for 2015-2016. The policy committees develop the League's legislative priorities and help League staff understand the real world implications of proposed legislation.

With the Florida Legislature convening the 2016 Legislative Session in January instead of March, the policy committee meetings will commence this June instead of September. This accelerated timeline means the proposed priorities adopted by each policy committee will then be submitted to the Legislative Committee and then ultimately the FLC membership for consideration and adoption at the FLC Annual Conference instead of the FLC Legislative Conference. These priorities then become the League's Legislative Action Agenda.

In an effort to get more cities involved, the League is requesting that each city be represented on one or more of the League's Legislative policy committees. To submit your name and committee preference for consideration, please complete the online sign-up form by May 22, 2015 by clicking [here](#) or contacting Holly McPhail (hmcphail@flcities.com). Please note, even if you previously served, you must submit your name and committee preference for consideration.

Due to potential sunshine issues, only one elected official per city can be appointed to each committee. However, a city could have both an elected and non-elected city official serve on each of the five committees. Please be sure to coordinate your requests with your fellow elected officials before submitting to the League office.

President Matthew Surrency will confirm policy committee appointments on June 1st.

Appointed policy committee members are expected to attend the following meetings. Hotel information will be emailed to you upon completion of the online sign-up. The League is unable to reimburse travel costs.
