

**THIRD AMENDMENT TO AGREEMENT FOR
POLICE SERVICES**

This Third Amendment is entered into on January 27, 2014, by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of Dania Beach (the "CITY").

WHEREAS, on or about September 28, 2010, BSO and the CITY entered into an Agreement for Police Services; and

WHEREAS, on or about January 30, 2013, BSO and the CITY entered into a First Amendment to the Agreement for Police Services; and

WHEREAS, BSO and the CITY reached agreement on a Second Amendment to the Agreement for Police Services; and


WHEREAS, CITY is desirous of a reduction in staffing by removing one (1) Deputy Sheriff position and one (1) Community Service Aide position and modifying the consideration accordingly;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained in this Amendment, the parties agree as follows:

1. The staffing structure shall be decreased by one (1) Deputy Sheriff position and one (1) Community Service Aide position and the consideration adjusted accordingly, resulting in a Revised Exhibit "A", which is attached to and is incorporated into this Amendment by this reference.
2. Except as otherwise modified in this Amendment, the terms and conditions of the Agreement shall remain in full force and effect.



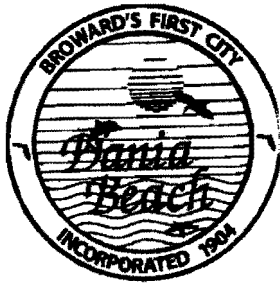
