FINAL ORDER ON REPEAT VIOLATION

This proceeding came on for Formal Hearing on August 5, 2010, after notice. Based upon the evidence presented, the Code Compliance Special Magistrate makes the following findings of fact and conclusions of law:

a. The Code Compliance Special Magistrate has jurisdiction of the Respondent and the subject matter of this action;

And

- b. Respondent, Frank West, did allow the following code violation to exist at property Respondent owns, located at 149 Northwest 14 Avenue, Dania Beach, Florida, which property is legally described as: REV PLAT BLK 6 & TR B OF PLAT OF WEST MOORLAND 24-38 B LOT 1 & 2: (0233 11 0010).
- 1. DBCC 13-34 (a) Nuisance Accumulation. It is unlawful for any owner or operator of premises within the city to allow the accumulation of or to accumulate any garbage, litter, stagnant water, trash, untended vegetation, or to allow any discoloration, or any

nuisance as defined in section 13-21 upon the premises. There is trash, litter, junk and debris on the premises. All trash, litter, junk and debris on the premises must be removed.

- c. The code inspector found the violation of DBCC 13-34 (a), as stated above, did exist on the above referenced property on July 9, 2010, and the violation has not been corrected to date.
- d. Respondent, Frank West, was previously found by the Dania Beach Special Magistrate in the Final Order dated November 5, 2007, Case Number 07-1919, to be in violation of DBCC 13-34 (a).
- e. The prior violation of the above referenced code section occurred within five years of Respondent's current violation DBCC 13-34 (a), as stated in paragraph b.(1) of this Final Order.
- f. The violation in this case is a repeat violation pursuant to Florida Statute 162.04(5), and a fine of \$500.00 per day will begin running on August 26, 2010 for the violation listed in paragraph b.(1).
- g. The fine shall constitute a lien against the above-described real property and it shall be a lien against any other real or personal property owned by Respondent.
- (a) In addition, there is also assessed a fine of \$200.00 to cover costs incurred by the City in the prosecution of this matter. Said amount is now due, and must be paid prior to the compliance date as ordered. If not paid, this fine may also constitute a lien against the above referenced property which may also be actionable by law.



Upon complying, the Respondent MUST notify the City's Code Compliance Department and an officer will inspect the property and notify the Code Compliance Special Magistrate whether Respondent has complied.
