## **Requested Action:**

Approval of the Settlement Received for: Marton Services, 2365 SW 34 Street #3 and #7, Case #09-1960 and Case #09-1964 due to sale of the property.

## Summary Explanation & Background:

## Case #09-1960

This was originally cited on 10/16/2009 for 1 violation and was given 30 days to comply. This went to the Special Magistrate on 1/7/2010 for 1 violation. Special Magistrate Mark Berman issued an order giving the respondent until 2/16/2010 to comply or a fine of \$150.00 per day would be levied. At the 9/2/2010 hearing, Special Magistrate Mitchell Kraft confirmed the fine as a lien. At the 3/3/2011 hearing, Special Magistrate Gordon Linn granted a continuance to 6/2/2011. At the 6/2/2011 hearing, Special Magistrate Mark Berman granted authorization to foreclose. The fines ran from 2/16/2010 through 5/21/15, 1,920 days @ \$150.00 per day = \$288,000.00 plus admin fees of \$258.00 for a total of \$288,258.00.

## Case #09-1964

This was originally cited on 10/16/2009 for 1 violation and was given 30 days to comply. This went to the Special Magistrate on 1/7/2010 for 1 violation. Special Magistrate Mark Berman issued an order giving the respondent until 2/16/2010 to comply or a fine of \$100.00 per day would be levied. At the 9/2/2010 hearing, Special Magistrate Mitchell Kraft confirmed the fine as a lien. At the 3/3/2011 hearing, Special Magistrate Gordon Linn granted a continuance to 6/2/2011. At the 6/2/2011 hearing, Special Magistrate Mark Berman granted authorization to foreclose. The fines ran from 2/16/2010 through 5/21/15, 1,920 days @ \$100.00 per day = \$192,000.00 plus admin fees of \$258.00 for a total of \$192,258.00.
