To the Dania Beach City Commission:

Previously, I've met each of you, but I wanted to provide this letter of introduction as part of my application for appointment to an opening on this Commission. This opening is an opportunity to bring true diversity to the Commission, not racial diversity, not gender diversity, not orientation diversity, but what I call "experiential diversity." The broader the range of experience on the City Commission, the more likely it is that someone on the Commission can tell the difference between someone who is telling a good story rather than is willing and able to do a good job or deliver a project on time. Diversity of experience is essential for any municipal commission, but especially for one that operates under "weak commission, strong city" paradigm.

I have had successful experience in at least four professional capacities: working the in clinical working as a clinical laboratory administrator, practicing medicine as a PA, and teaching school. Since I am agreeing, if appointed, not to run for election what follow are my understanding of five proposals be that wil be before this Commission before the next election.

- I. Ingress and egress from the near north-west, especially for children going to and from Attucks Middle School is not adequate. And, without going into any further detail, there have been tragic results. Looking at the Lori Parrish' maps, the land and rights-of-way are readily available. With proper authority it is a one-week job; In the setting of a municipal government it will take longer. This process ought to be easily completed in 8 months.
- II. Commissioner Grace recently expressed interest in obtain a Tree City USA designation. My experience both as a botany major and life-long-gardener would be helpful in accomplishing this goal. Norris, Tennessee, where I grew up and, incidentally, where my interest in municipal government began, has proudly been a Arbor Day Foundation designated Tree City USA. The process would require changes to bring Dania Beach's code into compliance with the Arbor Day Foundation's guidelines. This process ought to be easily completed in 8 months.

- III. Dania Beach is effective habitat for the mosquito, *Aedes aegypti*, the vector for the Zyka virus that Brazilian researchers have associated with microcephaly and, possibly, other human birth defects.. It is all-but-inevitable that a few exogenous cases of Zyka virus will be found in Broward County. It is axiomatic in Infectious Disease that control efforts are always reactive when they should have been proactive. Prevention always trumps treatment. Zyka will become politicized and with near-exquisite mosquito control Zyka has a minimal chance of becoming endemic in Dania Beach. Single specimens of Ad. aegypti spend their entire life-cycle in a 500 yard radius; consequently active and insightful monitoring of Broward County's Mosquito Control Board's approach to surveillance almost assures prevention of endogenous cases.
- IV. I am concerned that the language presented to this Commission by the Dania Beach Charter Review Board regarding the replacing vacancies in this Commission opens the City to unnecessary legal liability. Elected public officials and their appointed staff are exempted from the Family Medical Leave Act of 1983, but they are not exempt from the Florida Domestic Violence Leave Act. I've given the matter some thought and, while I agree with the spirit of the changes, I feel the approach should be more nuanced if, God-forbid, a situation arises where a commissioner is unable to serve temporarily and is eligible for the protections of the Florida Domestic Violence Leave Act [Section 741.313, Florida Statutes 92007)].
- V. Similarly, while I have some sympathy for the Charter Review Board's thoughts regarding the editing of recordings of meetings, to prevent a news organization or "citizen journalist" from doing so appears to me to constitute prior restraint and is in conflict with the 1st Amendment to the United States Constitution. To me it makes no sense to put the City in a position where it might have to defend a challenge on 1st amendment grounds. Anyone aggrieved by misleading or inaccurate statements has available civil recourse for libel and/or slander. I look forward to an opportunity to discuss the skills I can bring to the City Commission in greater detail.
