Consideration of the Abatement Request for: Joseph Herold, 4542 SW 25 AVE, Case #12-1026.

Summary Explanation & Background:

For Case #12-1026: This was originally cited on 11/6/12 for 6 violations. This went to the Special Magistrate on 7/11/13 for 5 violations. The Special Magistrate issued an order giving the respondent until 10/19/13 to comply the violations or a fine of \$150.00 per day would be levied. At the 1/19/14 hearing, an extension was granted until 4/19/14. At the 8/7/14 hearing, the Special Magistrate confirmed the fine as a lien. The property was brought into compliance on 12/2/15. The fines ran from 10/19/13 through 12/2/15, 774 days @ \$150.00 per day = \$116,100.00 plus recording/admin fees of \$271.00 totaling \$161,371.00. At the 12/3/15 hearing, Special Magistrate Bruce Jolly recommended an abatement of the fine to \$8,880.00 to the City Commission. **The out of pocket cost to the city are \$1,500.**

This proceeding came on for hearing for Authorization for Money Judgment on December 3, 2015, after notice. Based upon the evidence presented, the Code Compliance Special Magistrate makes the following findings of fact and conclusions of law: 1.
