Summary Explanation & Background:
For Case #14-2335: This was originally cited on 12/1/14 for 2 violations. This went to the Special Magistrate on 3/15/15 for 2 violations. The Special Magistrate issued an order giving the respondent until 4/14/15 to comply the violations or a fine of \$200.00 per day would be levied. At the 11/5/15 hearing, the Special Magistrate confirmed the fine as a lien. The property was brought into compliance on 11/12/15. The fines ran from 4/14/15 through 11/12/15, 212 days @ \$200.00 per day = \$42,400.00 plus recording/admin fees of \$312.50 totaling \$42,712.50. At the 2/4/16 hearing, Special Magistrate Bruce Jolly recommended an abatement of the fine to \$4,240.00 to the City Commission. The out of pocket cost to the City are \$1,200.

FINAL ORDER OF THE DANIA BEACH CODE COMPLIANCE SPECIAL MAGISTRATE

This proceeding came on for Formal Hearing on March 5, 2015, after notice. Based upon the evidence presented, the Code Compliance Special Magistrate makes the following findings of fact and conclusions of law:

- a. The Code Compliance Special Magistrate has jurisdiction of the Respondent and the subject matter of this action;
 and
- b. Respondent, SDS Development & Trust LLC, did allow the following code violations to exist at property Respondent owns, located at 2632 W Griffin Road, Dania Beach, Florida, which property is legally described as: REED LAND CO SUB 2-32 D 32-50-42 LOT 9 N 296 LESS E 300 & LESS W 255 & LESS W 5 OF E 305 OF S 93.63 OF N 296 & LESS N 35 FOR CO RD BLK 1 PAR M LESS E 5 OF S 93.63 OF N 296 SP LESS THAT PORTION LYING WITHIN LIMITS OF CITY OF DANIA: (0232 02 0440).
- 1. DBCC 13-34 (a) Nuisance Accumulation. It is unlawful for any owner or operator of premises within the city to allow the accumulation of or to accumulate any garbage, litter, stagnant water, trash, untended vegetation, or to allow any discoloration, or any nuisance as defined in section 13-21 upon the premises. There is overgrowth of untended vegetation the property. All overgrowth must be cut.

2. DBLDC 100-40 (d) Prohibited Use. Any use not specifically listed as a permitted use or a special exception use for the subject property's zoning district is prohibited. There is prohibited exterior storage of a liquid storage tank in a commercially zoned district.

Upon consideration thereof, it is thereupon ORDERED:

- Respondent SDS Development & Trust LLC:
- (a) has been found to be in violation of the above described code sections listed in paragraphs b.(1) and b.(2), and a fine of \$200.00 per day will begin running on April 14, 2015 for these violations.
- (b) In addition, there is also assessed \$150.00 to cover costs incurred by the City in the prosecution of this matter. Said amount is now due, and must be paid prior to the compliance date as ordered. If not paid, this cost assessment may also constitute a lien against the above referenced property which may also be actionable by law.

The fine shall continue until said violations come into compliance with said sections of the City Code upon requested inspection. Upon complying, the Respondent MUST notify the City's Code Compliance Department and an officer will inspect the property and notify the Code Compliance Special Magistrate whether Respondent has complied. If the Respondent does not notify the City's Code Compliance Department, an officer will not inspect the property and the fine will continue to be imposed each day until a Code Officer is notified, inspects the property and determines the property to be in compliance with this order. Said fine shall constitute a lien upon the real property and personal property of the Respondent.

In the event this Final Order is recorded as a lien, a charge will be imposed to record the Final Order and any lien satisfaction.
