#### Requested Action

**MOTION TO AWARD** fixed contract to low bidder, Ric-Man Construction Florida, Inc., for UAZ 314, UAZ 316 and UAZ 318 Water and Sewer Improvements, Bid No. Y1200707C1, for Water and Wastewater Services, in the estimated amount of \$10,143,171, which includes Bid Add Alternate Item No. 107; plus allowance items for permits, fees and performance and maintenance required security in the estimated amount of \$409,912, to be completed in 365 calendar days from the Second Notice to Proceed, with a total potential contract amount of \$10,553,083, contingent upon the receipt and approval of insurance/performance and payment guaranty, and authorize the Mayor and Clerk to execute the same. (Project Number 9068) (**Commission District 7**)

#### Why Action is Necessary

In accordance with the Broward County Procurement Code, Section 21.31.a.4, the Board is required to approve all purchases exceeding \$250,000.

#### What Action Accomplishes

Provides all labor, materials, equipment, services and incidentals for the construction of infrastructure site work throughout Broward County, including, but not limited to site preparation and earthwork.

#### Summary Explanation/ Background

THE PURCHASING DIVISION AND THE PUBLIC WORKS DEPARTMENT/WATER AND WASTEWATER SERVICES RECOMMEND APPROVAL OF THE ABOVE MOTION.

The Office of Economic and Small Business Development (OESBD) established a County Business Enterprise (CBE) goal of 20% for this contract. Ric-Man Construction Florida, Inc. committed to 20.09% CBE participation, which has been reviewed and approved by the OESBD (Exhibit 2).

The purpose of this contract is to provide all labor, materials, equipment, services and incidentals for the construction of infrastructure improvements throughout Broward County, including but not limited to site preparation, site furnishings, earthwork, roadway and walkway replacement, sanitary sewer and waters systems installation, restoration of landscape, existing irrigation systems and pavement marking.

The allowance items included in this contract, in the estimated total amount of \$409,912, include \$32,460 for Broward County's permit fees, \$316,252 for City of Dania Beach's permit fees, \$1,200 for State of Florida Department of Environmental Protection's National Pollutant Discharge Elimination System Stormwater permitting fees and \$60,000 for Performance and Maintenance Required Security. Expenditures under these allowance items must be approved by the Contract Administrator and will be reimbursed at the contractor's actual incurred cost, without mark-up (Exhibit 1: Lines 104 through 106A).

This procurement carries a 100% performance and payment guaranty. The Purchasing Division has confirmed with the

surety company that Ric-Man Construction Florida, Inc. has the capacity to obtain the required guaranty.

The amounts referenced in this agenda item have been rounded to the nearest whole dollar. Vendor payments will be based on the actual total bid amount. The bid tabulation reflects the actual amount of the award.

Water and Wastewater Services has reviewed the bid submitted by Ric-Man Construction Florida, Inc., and concurs with the recommendation for award (Exhibit 3). No vendor performance evaluations are available in Contract Central for Ric-Man Construction Florida, Inc.

There was no protest or appeal filed regarding this procurement.

The bid posted on December 13, 2013 and opened on January 22, 2014; nine bids were received with no declinations (Exhibit 1).
