#### **Requested Action:**

Approval of the Settlement Received for: Ricardo & Ismalie Jean Charles, 3951-3953 SW 51 ST, Case #11-0473 & Case #13-1361.

### **Summary Explanation & Background:**

For case #11-0473 this was originally cited on 4/6/11 for 1 violation. This went to the Special Magistrate on 7/7/11 for 1 violation. The Special Magistrate issued an order giving the respondent until 8/16/11 to comply the violations or a fine of \$250.00 per day would be levied. The fines ran from 8/16/11 through 4/20/16, 1,709 days @ \$250.00 per day = \$427,250.00.

For case #13-1361 this was originally cited on 8/16/13 for 8 violations. This went to the Special Magistrate on 12/12/13 for 8 violations. The Special Magistrate issued an order giving the respondent until 1/1/14 to comply the violations or a fine of \$100.00 per day would be levied. At the 4/2/15 hearing Special Magistrate Bruce Jolly confirmed the fine. The fines ran from 1/1/14 through 4/20/16, 804 days @ \$100.00 per day = \$84,000.00. This is a motion to accept the settlement offer received by the City due to sale of property. The City received \$3,268.56 as settlement for the fines.
